Motion by Werkmeister, second by Unrau to authorize the sale of the City's old snow blower. All ayes. Motion carried. Motion by Honkomp, second by Jacobs to approve the moving of the west Paullina sign. All ayes. Motion carried.

Council discussed the City's future involvement with the Swanson Sports Complex. Motion by Unrau, second by Jacobs to approve researching the removing of the City of Paullina from any involvement with the Swanson Sports Complex. All ayes. Motion carried.

Reports: Superintendent of Utilities Top discussed downtown lighting and cameras for the tree dump. Top also informed the Council that Iowa DNR will be doing another tree inventory at no cost to the City. Top shared with the Council that DGR Engineering found that a water system Hydraulic Model had been completed in 2013which will decrease the engineering fees associated with the water system study. Mayor Sjaarda informed the Council that he had visited with the Hospers Mayor regarding their Fire Station, and shared that the City has an interested party for the old Mercy clinic. Fire Chief Ryan Harper informed the Council that the Chili Dinner/Open House went well and that they received good feedback.
